Trustee Butterfield moved to approve the minutes of the regular board meeting of November 13, 2012, second by Trustee Esker. All ayes, motion carried.

**COMMUNICATIONS:** President Yokley presented certificates to Becky Finley and Brenda Marshall for their hard work and leadership on the Williamsville Alumni Reunion and the Williamsville Fall Festival.

**COMMITTEE REPORTS:**

**FINANCE (Skylar Tierney):** Trustee Tierney made a motion to pay bills as presented, seconded by Trustee Carter. All ayes, motion carried.

Trustee Tierney stated all 2013 budget items need to be submitted to the Treasurer by Dec. 4<sup>th</sup>. President Yokley prepared everyone that there will be some budget reductions.

Trustee Tierney made a motion to pass Ordinance #2012-11, An Ordinance of the Village of Williamsville, Illinois Levying Taxes for the Fiscal Year January 1, 2012 to December 31, 2012. Trustee Carter seconded the motion. All ayes, motion carried.

Trustee Tierney made a motion to pass Ordinance #2012-12, An Ordinance of the Village of Williamsville, Illinois to Increase the Charge for Billing for Sewer Charges for the Village of Sherman Residents. Trustee Carter seconded the motion. All ayes, motion carried.

**PUBLIC SAFETY (Scott Butterfield):** Trustee Butterfield stated the Police Chief has tried to contact the trapper for the nuisance animals. As of this time, he had not returned the Chief's call.
