AN ORDINANCE AMENDING CHAPTER 158, FENCES OF THE CODE OF THE VILLAGE OF WILLIAMSVILLE

NOW THEREFORE, be it ordained by the President and Board of Trustees of the Village of Williamsville the Village Board as follows:

Section 1: Chapter 158, Fences of the Code of the Village of Williamsville is amended to read as follows:

**CHAPTER 158
FENCES**

§158-1. Definitions.

As used in this Chapter, the following terms shall have the meanings indicated:

FENCE- An enclosure, barrier or boundary made of posts, boards, wood, wire, stakes or rails.

§158-2. Prohibitions.

No fence may be electrified within the Village limits of the Village of Williamsville, Illinois nor may any electrified fence be constructed within the Village.

§158-3. Finished Exterior Side.

- A. Fence Construction. Except for a fence required to be constructed pursuant to Chapter 210 of this Code of the Village of Williamsville, any fence built or constructed within the Village of Williamsville, Illinois, shall have a finished exterior side.
- B. Existing permanent fences. The requirements for a fence to have a finished exterior side shall not apply to an existing permanent fence in place on the effective date of this Chapter. An existing permanent fence which is more than 49.0% removed, damaged, destroyed or enlarged shall be installed, enlarged, repaired or constructed pursuant to the regulations contained herein in §158-3(A) of this Chapter.

§158-4. Penalties.

A person convicted on violating this ordinance shall be fined not less than \$50.00 nor more than \$750.00. Each day of violation shall constitute a separate offense.

Section 2: If any part of this ordinance or the application thereof to any person or circumstances is deemed invalid, the remainder of the Ordinance, including the application of such part or provision to other persons or circumstances shall not be affected thereby and shall continue in full force and effect.

Section 3: Except as amended by this Ordinance, all other provisions and sections of the Code of the Village of Williamsville, Illinois, as amended, shall remain in full force and effect.

Section 4: This Ordinance shall be published by the Village Clerk in pamphlet form and shall take effect and be in full force from and after its passage and approval as required by law.
