

**MINUTES OF THE REGULAR BOARD OF THE BOARD OF TRUSTEES FOR
THE VILLAGE OF WILLIAMSVILLE**
May 10, 2021

The Town Hall/board meeting was called to order at 6:30 pm by President Yokley. Clerk: Karen Winger.
Trustees Present or via telephone: Gettlemann, Carter, Bunger, Brennan, Hofferkamp, Tierney.

GUESTS: Kevin Foran

COMMUNICATIONS: Trustee Brennan made a motion to approve the minutes of the regular board meeting held on April 26, 2021. Trustee Hofferkamp seconded the motion. All ayes, motion carried.

Courtney Gray swore in President Yokley, Trustee Skylar Tierney, Trustee Matt Bunger, and Trustee John Brennan. Oaths were taken.

President Yokley swore in Courtney Gray as Deputy Clerk. Oath was taken.

Kevin Foran was present at the meeting. Foran discusses issues that occurred just outside of town last weekend, and the response time for the county to arrive on scene. He requested something be done to look into better way for quicker response times by officers in the future. President Yokley stated they've met with the Sheriff and Jack Campbell in past and States Attorney turned them down. President Yokley would like to set up a meeting to Dan Wright, along with Trustee Brennan and Chief Edwards.

COMMITTEE REPORTS:

FINANCE (Tierney): Trustee Tierney had nothing new to report.

PUBLIC SAFETY (John Brennan): Trustee Brennan stated there will be a Public Safety meeting tomorrow, May 11, 2021, to discuss the cat problems and nuisances around the Village.

President Yokley also stated there was vandalism at the new playground, and the camera system helped identify the individuals responsible. There will be restitution for employee's and officer's pay and the cleaning. There will also be community service hours for the individuals to complete.

WATER & SEWER (Matt Bunger): Trustee Bunger stated Kent is reviewing some changes from Kevin Kuhn with the new water/sewer system, and then the project will go to bid.

ECONOMIC DEVELOPMENT (Hofferkamp): President Yokley stated the Community Center capacity is currently at 50%, or 62 people, due to COVID-19.

President Yokley also gave an update on the Community Center. It has been painted and flooring will begin Thursday, May 13. Yokley also stated the Village has not met an agreement with the original contractor, and the stain for the bricks has not been dropped off. A final payment will not be issued until the stain is dropped off. Correspondence has been made with the contractor.

PARKS & RECREATION (Dave Carter): Trustee Carter invited everyone to Picnic in the Park this Sunday and hopes for good weather for the event.

Trustee Carter also stated the Healthy Kids Running Series is doing well.

STREETS, ALLEYS, SIDEWALKS & STORM SEWERS (Patrick Gettleman): Trustee Gettleman had nothing new to report.

President Yokley stated the road to Parkwood Estates has been paved.

Trustee Carter mentioned there was a large hole on Main Street going out of town. President Yokley stated he would have the public works department work on getting it fixed.

Trustee Tierney asked who was responsible for mowing the overpass. President Yokley stated the Village was. He said the Village will be getting a mower for the overpass.

ADDITIONAL BUSINESS: President Yokley stated with the board's permission he would like to have a letter go out to the Representative and State's Office urging to not reduce the state's income tax.

The regular board meeting of the Board of Trustees for the Village of Williamsville adjourned at 6:49 p.m.
