AN ORDINANCE AMENDING CHAPTER 155 OF THE CODE OF THE VILLAGE OF WILLIAMSVILLE, §155-14, PARAGRAPH F: WATER CONNECTION FEES (§301-7A)

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WILLIAMS VILLE THE VILLAGE BOARD AS FOLLOWS:

Section 1: Chapter 155, §155-14(F) of the Code of the Village of Williamsville is amended to read as follows:

§115-14 ...

F. Water Connection Fees (§301-7A):

Residential Water Connection (Tap) Fees:

- (a) \$1,400.00 for a 3/4 inch meter installed in a single residential unit;
- (b) \$1,700.00 for a one (1) inch meter installed in a single residential unit;
- (c) The actual cost of materials plus the sum of \$500.00 for a water meter in excess of one (1) inch up to and including two (2) inches;
- (d) In addition to the fees contained in subparagraphs (a), (b) and (c), the customer shall also reimburse the Village the costs of materials and labor associated with boring or crossing any and all streets, alleys, sidewalks, driveways or easements. Customer shall make said reimbursement payment to the Village within 20 days from the date customer is mailed an invoice for the same; and
- (e) All meters over two (2) inches will be installed by special or individual ordinance.

Non-Residential (Commercial) Water Connection (Tap) Fees:

- (a) \$1,400.00 for a 3/4 inch meter;
- (b) \$1,700.00 for a one (1) inch water meter;
- (c) The actual cost of materials plus the sum of \$500.00 for a water meter in excess of one (1) inch up to and including two (2) inches;
- (d) In addition to the fees contained in subparagraphs (a), (b) and (c), the customer shall also reimburse the Village the costs of materials and labor associated with boring or crossing any streets, alleys, sidewalks, driveway or easements. Customer shall make

said reimbursement payment to the Village within 20 days from the date customer is mailed an invoice for the same;

(e) All meters over two (2) inches will be installed by special or an individual ordinance.

Section 2: Except as amended herein by this Ordinance, all other provisions of the Code of the Village of Williamsville, Williamsville, Illinois, as Amended, shall remain in full force and effect.

Section 3: Any Ordinance or Section of the Village Code in conflict with the provisions of this Ordinance are hereby repealed to the extent of the conflict. If any part of this Ordinance be held void, such part shall be deemed severable and the invalidity thereof shall not affect the remaining parts of this Ordinance.

Section 4: This ordinance shall be published by the Village Clerk in pamphlet form and shall take effect and be in full force after its passage and required by Law.
