**AN ORDINANCE OF THE VILLAGE OF WILLIAMSVILLE, ILLINOIS REGARDING:
AMENDING CHAPTER 155 FEES SECTION 155-14 WATER AND SEWER,
PARAGRAPH K AND PARAGRAPH M**

WHEREAS, the Village of Williamsville operates the water system for its customers located within the corporate limits of the Villages of Williamsville and Sherman and certain customers outside the corporate limits of said Villages;

WHEREAS, the Village of Williamsville purchases the water for said system from CWLP of the City of Springfield;

WHEREAS, the City of Springfield has passed water rate increases, which effect the Village of Williamsville and its customers; and

WHEREAS, it is necessary for the Village of Williamsville to increase its water rate charges to its customers as a result of the City of Springfield water rate increases.

NOW THEREOFRE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WILLIAMSVILLE, THE VILLAGE BOARD FINDS AS FOLLOWS:

Section 1: All the above recitals are true, correct and are hereby incorporated into this Ordinance by reference

Section 2: That Chapter 155-14, Paragraph K of the Code of the Village of Williamsville shall be amended and modified as follows:

K. Water rates inside the Village limits of Williamsville and Sherman (§301-19):

| Gallons of Water Used | Rates |
|---|---|
| Up to 1,000 gallons per minimum bill | \$17.79 minimum |
| From 1,000 gallons and up to 5,000 gallons | \$17.79 plus \$1.28 per 100 gallons or fraction thereof, used over 1,000 gallons |
| From 5,000 gallons and up to 10,000 gallons | \$69.00 plus \$1.08 per 100 gallons, or fraction thereof, used over 5,000 gallons |
| 10,000 gallons and over | \$123.00 plus \$0.93 per 100 gallons, or fraction thereof, used over 10,000 gallons |

Section 3: That Chapter 155, Section 155-14, Paragraph M of the Code of the Village of Williamsville shall be amended and modified as follows:

M. Water Rates Outside the Village Limits of Williamsville and Sherman:

| Gallons of Water Used | Rates |
|---|---|
| Up to 1,000 gallons per minimum bill | \$20.75 minimum |
| From 1,000 gallons and up to 5,000 gallons | \$20.75 plus \$1.51 per 100 gallons or fraction thereof, used over 1,000 gallons |
| From 5,000 gallons and up to 10,000 gallons | \$81.15 plus \$1.28 per 100 gallons, or fraction thereof, used over 5,000 gallons |
| 10,000 gallons and over | \$145.15 plus \$1.08 per 100 gallons, or fraction thereof, used over 10,000 gallons |

Section 4: Effective Dates of Rates: The rates and service charges established for user charges in this Ordinance shall take effect and be in force from and after its passage and approval, as required by law on the bills to be rendered beginning with the June 2022 billing cycle.

Section 5: Except as amended herein by this Ordinance, all other provisions of the Code of the Village of Williamsville, Williamsville, Illinois, as amended, shall remain in full force and effect.

Section 6: Any Ordinance of Section of the Village Code in conflict with the provisions of this Ordinance are hereby repealed to the extent of the conflict. If any part of this Ordinance be held void, such part shall be deemed severable and the invalidity thereof shall not affect the remaining parts of this Ordinance.

Section 7: This Ordinance shall take effect and be in force from and after its passage and approval as required by law pursuant to roll call vote as follows:
