**AN ORDINANCE OF THE VILLAGE OF WILLIAMSVILLE, ILLINOIS
AMENDING THE CODE OF THE VILLAGE OF WILLIAMSVILLE BY
ADDING ITEM (16) TO CHAPTER 205 NUISANCES SECTION 205-1(B)**

WHEREAS, it is in the matter of the public health, safety and welfare of the citizens of the Village of Williamsville, Illinois, that the Village Code of the Village of Williamsville, Illinois, should be amended to regulate the length a disposal container and/or dumpster may be continuously be located on a lot or parcel of real estate in the Village of Williamsville, Illinois.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WILLIAMSVILLE, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: That the following be added as Item (16) to Chapter 205 Section 205-1(B) of the Code of the Village of Williamsville:

**Chapter 205
NUISANCES**

§205-1 PUBLIC NUISANCES DEFINED

B... 16. Disposal container and/or dumpster is defined as any container used for the storage, collection, or removal of construction debris, demolition debris, household refuse, or other discarded material. No disposal container or dumpster greater than 8 cubic yards in size shall be located on any lot or parcel of real estate in the Village of Williamsville for a period of more than 30 days per calendar year unless:

1. Said dumpster is stored on a property with an active construction or renovation project, and such container or dumpster is primarily used for disposal of waste materials from such project. The Village President on a case by case basis may extend the period in the event that the construction or renovation is temporarily interrupted or stopped; or
2. The property owner or their designee has obtained a permit for such container or dumpster from the Village of Williamsville by submitting an application to the Village President or his designee detailing the need for such container or dumpster, the length of time the container or disposal dumpster will be present, and where the disposal container or dumpster will be stored.

Section 2: Except as amended herein by this Ordinance, all other provisions of the Code of the Village of Williamsville, Williamsville, Illinois, as amended, shall remain in full force and effect.

Section 3: Any Ordinance or Section of the Village Code in conflict with the provisions of this Ordinance are hereby repealed to the extent of the conflict. If any part of this Ordinance be held void, such part shall be deemed severable and the invalidity thereof shall not affect the remaining parts of this Ordinance.

This Ordinance shall take effect and be in force from and after its passage pursuant to roll call vote as follows:
