“AN ORDINANCE AMENDING CHAPTER 285, ARTICLE I. SPEED LIMITS §285-1 SPEED LIMITS ESTABLISHED AND §285-3 PENALTIES OF THE CODE OF THE VILLAGE OF WILLIAMSVILLE”

NOW THEREFORE, be it ordained by the President and Board of Trustees of the Village of Williamsville the Village Board as follows:

Section One: Chapter 285 §285-1 Speed Limits Established of the Code of the Village of Williamsville is amended by deleting §285-1 in its entirety and amending §285-1 to read as follows:

§285-1. Speed limits established. No person shall drive a vehicle upon the streets within the Corporate limits of the Village of Williamsville at a speed greater than established by this Ordinance.

- (a) The speed limit for all streets within the Village of Williamsville shall be twenty (20) miles per hour unless otherwise posted or as in Section §285-1(b) herein.
- (b) Speed limits on certain streets located within the Corporate limits of the Village of Williamsville are as follow:

<u>Name of Street</u>	<u>Speed Limit (MPH)</u>	<u>Location</u>
(i) Main Street	25	Entire Length
(ii) Walnut Street	25	From Main Street to Corporate limits
(iii) Northbound Old Rt. 66	30	From Salem Street to Corporate limits
(iv) Southbound Old Rt. 66	30	From Main Street to Valor Parkway
(v) Valor Parkway	30	On Valor Parkway to its intersection with Walnut Street
(v) All Park and Lake Roads	10	Throughout Village Park or at Village Lake

- (c) Nothing in §285-1(a) or (b) shall modify or increase the speed limits in school speed limit zones.

Section Two: Chapter 285 §285-3 shall be amended to read as follows:

§285-3. Penalties. Every person convicted of a violation of any provision of this article shall be punished by a fine as follows:

- (a) Speeding from 1 to 15 mph in excess of the posted speed limit, the sum of \$75.00 for the first offense within a consecutive twelve (12) month period. For the second offense and each subsequent offense within a consecutive twelve (12) month period, the sum of \$150.00 per offense.

- (b) Speeding from 16 to 25 mph in excess of the posted speed limit, the sum of \$150.00 for the first offense within a consecutive twelve (12) month period. For the second offense and each subsequent offense within a consecutive twelve (12) month period, the sum of \$300.00 per offense.
- (c) Speeding over 26 mph in excess of the posted speed limit, the sum of \$300.00 for the first offense within a consecutive twelve (12) month period. For the second offense and each subsequent offense within a consecutive twelve (12) month period, the sum of \$600.00 per offense.

Section Three: If any part of this ordinance or the application thereof to any person or circumstance is deemed invalid, the remainder of the Ordinance, including the application of such part or provision to other persons or circumstances shall not be affected thereby and shall continue in full force and effect.

Section Four: Except as amended by this Ordinance, all other provisions and sections of Chapter 285 of the Code of the Village of Williamsville, Illinois, as amended, shall remain in full force and effect.

Section Five: This Ordinance shall be published by the Village Clerk in pamphlet form and shall take effect and be in full force from and after its passage and approval as required by law.
