**COMMUNICATIONS:**

Trustee Gettleman made a motion to approve the minutes of the Special Board Meeting held on October 28, 2024.  
Trustee Bunger seconded the motion. All ayes, motion carried.

Trustee Bunger made a motion to approve the minutes of the regular Board Meeting held on October 28, 2024. Trustee McMillan seconded the motion. All ayes, motion carried.

**COMMITTEE REPORTS:**

**FINANCE (Tierney):** Trustee Carter made a motion to pay monthly bills. Trustee Gettleman seconded the motion. All ayes, motion carried.

Heidi Darow provided each Trustee a copy of the preliminary budget worksheet. President Yokley reminded the Trustees to submit their budgets. Trustee Esker made a motion to approve the rezoning of the two vacant parcels (village owned) located in front of the new lake. The parcels addresses will be West Street. The property is being rezoned from a R-2 to R-1. Trustee McMillan seconded the motion. All ayes, motion carried.

**STREETS, ALLEYS, SIDEWALKS & STORM SEWERS (Patrick Gettleman):** Trustee Gettleman had nothing new to report.
