The Town Hall/board meeting was called to order at 6:00 pm by President Yokley. Clerk: Karen Winger

COMMUNICATIONS: President Yokley stated Boo on the Boulevard was a huge success.

Trustee Gettleman made a motion to approve the minutes of the regular board meeting held on October 15, 2024.
Trustee Bunger seconded the motion. All ayes, motion carried.

COMMITTEE REPORTS:

FINANCE (Tierney): Trustee Carter made a motion to pay monthly bills. Trustee Gettleman seconded the motion. All ayes, motion carried.

Trustee Esker made a motion to pass Ordinance # 2024-10, levying taxes for the fiscal year January 1, 2024 to December 31, 2024. Trustee Gettleman seconded the motion. All ayes, motion carried.

PUBLIC SAFETY (Sharon McMillan): Trustee McMillan stated the new squad (Durango) is approximately 90% complete.

WATER & SEWER (Matt Bunger): Trustee Bunger stated IDOT's Utility Permit has been signed for the boring under I-55 for the new proposed water line, when the old line gets abandoned. (Approximately a mile worth of water line is being abandoned.) Kent Thompsons stated the Village hasn't received any estimates for this project yet.

ECONOMIC DEVELOPMENT (Esker): Trustee Esker had nothing new to report.

PARKS & RECREATION (Dave Carter): The ordinance pertaining to the bicycles/scooters on the courts at the park, has been tabled at this time.

Trustee Carter thanked Public Works for the new concrete at the park for the new swing set.

STREETS, ALLEYS, SIDEWALKS & STORM SEWERS (Patrick Gettleman): Trustee Gettleman had nothing new to report.

ADDITIONAL BUSINESS: President Yokley stated Election Day was overlooked on the employees' holiday list. He stated the State and the County are both closed that day.

Trustee McMillan made a motion to approve Tuesday, November 5th as a holiday. Trustee Esker seconded the motion. All ayes, motion carried.

Trustee Carter made a motion to approve the 2025 holiday list. Trustee McMillan seconded the motion. All ayes, motion carried.

Trustee Bunger made a motion to approve the 2025 board meeting schedule. Trustee McMillan seconded the motion. All ayes, motion carried.
