AN ORDINANCE AMENDING CHAPTER 155, FEES §155-10 SEWERS PARAGRAPH D USER RATE: GALLONS OF SEWAGE TREATED OF THE CODE OF THE VILLAGE OF WILLIAMSVILLE

NOW THEREFORE, be it ordained by the President and Board of Trustees of the Village of Williamsville the Village Board as follows:

Section 1: Chapter 155, Fees §155-10 Sewers Paragraph D. USER Rate: Gallons of Sewage Treated of the Code of the Village of Williamsville is amended to read as follows:

| i.   | Up to 1,000 gallons:  | \$24.98 minimum  |
| ii.  | From 1,000 gallons and up to 3,000 gallons:   | \$35.57 minimum  |
| iii. | From 3,000 gallons and up:  | \$35.57, plus \$0.67 per 100 gallons, or fraction thereof, used over 3,000 gallons |
| iv.  | Non metered residential users:  | \$25.72 per month  |
| v    | On January 1 <sup>st</sup> of each year beginning on January 1, 2024 there shall be an automatic annual ten percent (10%) increase of the sewer usage rates charged as stated in this Paragraph D subsections i, ii, iii and iv. Said increases shall be in effect with the February billing cycle each year. |  |

Section 2: If any part of this ordinance or the application thereof to any person or circumstance is deemed invalid, the remainder of the Ordinance, including the application of such part or provision to other persons or circumstances shall not be affected thereby and shall continue in full force and effect.

Section 3: Except as amended by this Ordinance, all other provisions of the Code of the Village of Williamsville, Illinois, as amended, shall remain in full force and effect.

Section 4: This Ordinance shall be published by the Village Clerk in pamphlet form and shall take effect and be in full force from and after its passage and approval as required by law. The above sewer rates shall take effect to the sewer usage charges starting with the June, 2023 billing cycle.

Section 5: Any Ordinance of Section of the Village Code in conflict with the provisions of this Ordinance are hereby repealed to the extent of the conflict. If any part of this Ordinance be held void, such part shall be deemed severable and the invalidity thereof shall not affect the remaining parts of this Ordinance.

Section 6: This Ordinance shall take effect and be in force from and after its passage and approval as required by law pursuant to roll call vote as follows:
